- 12. Commissioner Huffman made a motion to approve the 2018 application for Regional Drug Court Enhancement Project Grant in the amount of \$36,647.00. These funds will be used for non-traditional hours of probation officers for RDC visits, testing supplies, treatment costs and incentive items based on seven RDC clients. Commissioner Wimer seconded the motion. The motion carried unanimously.
