### A RESOLUTION OF THE COMMISSIONERS OF FOREST COUNTY, PENNSYLVANIA, AMENDING THE INTERGOVERNMENTAL COOPERATION AGREEMENT WITH THE PENNSYLVANIA DEPARTMENT OF TRANSPORTATION OF THE ELM STREET BRIDGE REHABILITATION PROJECT

WHEREAS, Forest County has entered into an Intergovernmental Cooperation Agreement with the Pennsylvania Department of Transportation for the Elm Street Bridge Rehabilitation Project; and



NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Forest County, Pennsylvania that the Forest County Board of Commissioners approve that the total incurred costs for Preliminary Engineering at \$100,000.00, Right-of-Way at \$0.00 and Construction at \$1,046,869.00 for a total project cost of \$1,146,869.00 for the Elm Street Bridge Rehabilitation Project shall be split at 80% expenditure amount of \$917,495.20 for federal funds, 15% expenditure amount of \$172,030.35 for state funds and 5% expenditure amount of \$57,343.45 for county funds.


